- **Financial Institutions** panel led by Banco Santander Global RM (confirmed) on best use of captive, insurability of operational risk, and impact on regulatory capital requirements.
- **Technology sector** panel led by Telefonica Global RM (confirmed) on human error contract breach
- **Energy industry** panel led by Promigas Insurance coordinator (confirmed)
